



What is a Continuum of Care?

- Authorized by the McKinney-Vento Homeless Assistance Act (1987)
- Amended by Homeless Emergency Assistance and Rapid Transition to Housing (HEARTH) Act (2009)
- Federal regulations (24 CFR 578)
 - Interim & Final Rules, and HUD Memos
- Department of Housing and Urban Development (HUD)
 - Special Needs Assistance Programs (SNAPs)



What is a Continuum of Care?

- A federally mandated program, tasked with the coordination of homeless services activities across a specified geographic area
- Designed to assist people experiencing homelessness by providing the housing and/or services needed to obtain and maintain permanent housing



Rhode Island Statewide Continuum of Care (RICoC)

- Promote a communitywide commitment to employ best practices to end homelessness in Rhode Island;
- Secure funding for efforts by providers and government entities to prevent homelessness and quickly re-house homeless individuals, unaccompanied youth, and families in Rhode Island, while minimizing the trauma and dislocation that homelessness causes to individuals, families, and communities;
- Promote access to and effective utilization of mainstream programs by homeless individuals and families; and
- Optimize self-sufficiency among individuals and families that experience homelessness





Responsibilities of the RICoC

🚢 🛛 Governance Charter

Membership, Board of Directors and Committees

Set performance targets, monitor performance, and take action against poor performance for CoC grant recipients

Coordinate with Emergency Solutions & other HUD Grant Recipients


Develop Written Standards (Policy Standards) for CoC Housing Programs

Designate Lead Agencies and a single Homeless Management Information System

Submit funding applications, includes local selection of projects for new and renewal funding




Current Permanent Housing Uses:

- New Construction


Homelessness in Rhode Island



Continuum of Care 3/25/2025

Strengths

- 303% increase in competitive national funding since 2017
- Consistent, rapid responses to emerging federal grant opportunities
- Partnering and collaborating on federal and local initiatives to increase impact
 - Housing Authorities
 - Medicaid
- National and Local Technical Assistance & Training leader



Challenges

- Increased rates of homelessness, unsheltered homelessness and "chronic" long-term homelessness in Rhode Island
- Lack of available, safe and habitable units
- Lack of direct ability to address "Inflow" into RI's homeless system with upstream prevention solutions
- Rigid federal definitions of "homeless" and record keeping requirements create gaps in who federal programs can help
- Federal outlook

Opportunities

- Collaboration with ICH, Housing Authorities, Department of Housing and Rhode Island Housing to braid federal and local initiatives and increase as opportunities present (Pipeline Committee)
- Collaboration with Philanthropic organizations, CRA offices, Health Insurance and Health Care Systems to increase impact and align opportunities with shared goals (Funding Committee)
- Ecosystem Data Request to identify upstream opportunities for policy solutions to end discharges into homelessness from feeder systems (HMIS Committee)
- Assure crisis services are available for those who are outside (CES Implementation Committee)
